PROPOSAL: Recognize Funds and Approve Drayage Truck Replacement

Projects for "Year 3" Proposition 1B-Goods Movement Program, Amend Truck Replacement Award and Execute Contract for Truck

Retrofits

SYNOPSIS: CARB has recently solicited and evaluated drayage truck

applications in the Los Angeles/Inland Empire and the Bay Area goods movement corridors to fund drayage trucks as priority before distributing the balance of the "Year 3" Proposition 1B-Goods Movement Program funds to other truck projects. These actions are to recognize up to \$5,071,500 under the FY 2009-10 "Year 3" Proposition 1B-Goods Movement Program and to approve funding of drayage truck projects subject to CARB's final evaluation and

approval in an amount not to exceed \$4,830,000 from the Proposition 1B-Goods Movement Program Fund (81). These actions are also to amend a truck replacement award under the Proposition 1B-Goods Movement Program and to execute a

contract to retrofit 32 trucks for \$160,000 from the U.S. EPA funds

previously placed in the Clean Fuels Fund (31).

RECOMMENDED ACTIONS:

- 1. Recognize up to \$5,071,500 from CARB as part of the FY 2009-10 Proposition 1B-Goods Movement Program funds for truck projects and place them into the AQMD's Proposition 1B-Goods Movement Program Fund (81).
- 2. Authorize the Executive Officer to:
 - a. Execute contracts for drayage truck replacement projects as listed in Table 1, contingent upon CARB's final approval, in an amount not to exceed \$4,830,000, from the "Year 3" Proposition 1B-Goods Movement Program fund (81);
 - b. Amend a truck replacement award for name change from Van Dyke Tank Liner, Inc. DBA Cool Transports to Nuckels Oil Company, Inc. DBA Merit Oil Co. under the Proposition 1B-Goods Movement Program;

c. Execute a contract with RRM Properties for the retrofit of 32 trucks in an amount not to exceed \$160,000 from the U.S. EPA funds placed in the Clean Fuels Fund (31).

Background

At its December 2011 meeting, CARB Board approved the procedures for distribution of the FY 2009-10 "Year 3" Proposition 1B-Goods Movement Program funds and the selection of project categories. The priority was to allow a final funding opportunity for drayage trucks at the ports in the Los Angeles/Inland Empire and the Bay Area goods movement corridors and then distribute the remaining funds for "other trucks" among the participating corridors based on the overall distribution percentages adopted by CARB at the commencement of the program.

The AQMD was awarded \$1 million from the U.S. EPA under the Diesel Emissions Reduction Act (DERA) to retrofit 200 heavy-duty diesel trucks with particulate traps. To date, 168 trucks have been retrofitted, but there is a balance of \$160,000 remaining from returned projects. This balance must be used to retrofit 32 additional trucks or the funding reverts to U.S. EPA.

Proposal

CARB has solicited and evaluated applications for drayage trucks operating at the ports in the Los Angeles/Inland Empire and the Bay Area trade corridors. Applications for 163 trucks were received for the Los Angeles/Inland Empire trade corridor. These actions are to recognize up to \$5,071,500 from CARB under the FY 2009-10 "Year 3" Proposition 1B-Goods Movement Program and to approve funding of the drayage truck projects as listed in Table 1, subject to CARB's final approval in an amount not to exceed \$4,830,000, from the Proposition 1B-Goods Movement Program Fund (81). Administrative funds for this grant are \$241,500.

This action is also to amend a truck replacement award for name change from Van Dyke Tank Liner, Inc. DBA Cool Transports to Nuckels Oil Company, Inc. DBA Merit Oil Co. under the Proposition 1B-Goods Movement Program.

RRM Properties applied and was approved for the retrofit of over 100 trucks under the "Year 2"Proposition 1B-Goods Movement Program on November 4, 2011. RRM

Properties has agreed to retrofit 32 of those trucks that were awarded \$10,000 per unit and their ranking was below 1,500 at \$5,000 per unit with the U.S EPA DERA funds instead of the Proposition 1B funds. Thus, this action is to execute contract with RRM Properties for the retrofit of 32 trucks in an amount not to exceed \$160,000 from the U.S. EPA funds placed in the Clean Fuels Fund (31).

Outreach

The drayage trucks were solicited and evaluated by CARB in accordance with their outreach policies. The remaining trucks were solicited earlier by the AQMD. In accordance with AQMD's Procurement Policy and Procedure, a public notice advertising the RFP/RFQ and inviting bids was published in the Los Angeles Times, the Orange County Register, the San Bernardino Sun, and Riverside County Press Enterprise newspapers to leverage the most cost-effective method of outreach to the South Coast Basin.

Additionally, potential bidders may have been notified utilizing AQMD's own electronic listing of certified minority vendors. Notice of the RFP/RFQ has been emailed to the Black and Latino Legislative Caucuses and various minority chambers of commerce and business associations, and placed on the Internet at AQMD's website (http://www.aqmd.gov). Information is also available on AQMD's bidder's 24-hour telephone message line (909) 396-2724.

Benefits to AQMD

The successful implementation of the truck projects will reduce NOx, PM and other pollutant emissions in a cost-effective and expeditious manner which will help achieve the goals of the 2007 AQMP. The new equipment/vehicles funded under this program are expected to operate for many years which will provide long-term emission reduction benefits in the region.

Resource Impacts

Total funding for the drayage truck projects listed in Table 1 shall not exceed \$4,830,000 from the Proposition 1B-Goods Movement Program Fund (81). Funding for the truck retrofit projects shall not exceed \$160,000 from the U.S. EPA funds previously placed in the Clean Fuels Fund (31).
